## **DEAR FRIENDS,**

Despite the challenges to our healthcare system and community over the last year, I'm grateful for the dedication and ingenuity of our teammates to continue the work of our mission. The pandemic highlighted many social and health inequities, and our teams responded with unparalleled dedication to serving those in need.

We collaborated with local churches to provide fresh produce to seniors experiencing food insecurity and established community partnerships to expand our reach in the rural community. Working with law enforcement and drug prevention agencies, we hosted Medication Take Back events to provide education on the opioid epidemic and safe medication disposal. Through these events, we collected 591 pounds of unused or expired medications to help keep our community safe.

We contributed a total of 5.5 percent, or \$55.4 million, of our net operating expenses in community benefit. That figure includes \$29.4 million in charity care and \$1.6 million in community outreach. Teammates donated 3,033 hours of staff time supporting community and health-related initiatives serving 9,753 residents.

Thank you to our teammates and community partners who work hand-in-hand to create a healthier, more equitable environment for all Tri-County residents.




#### **2020 COMMUNITY BENEFIT REPORT**
